

## Registration form for the ABT e-Line web portal

### Applicants must meet a range of conditions in order to be recognised as an ABT e-Partner:

- A contract with ABT e-Line has to be signed
- ABT training certificates from a VW training centre for individual employees are to be provided and added to the ABT e-Line website in PDF format. This can be uploaded on the ABT e-Line website as part of the registration as an ABTe partner, or after the Aftersales training has been successfully attended.
- A one-off payment of €2,995 for the diagnostic/special tool supplied by the company ABT and a monthly licence/support fee of €74 are required. The prices are subject to statutory VAT. ABT e-Line GmbH offers a discount of 3% for the monthly licence/support fee if the payment is made via direct debit. The diagnostic/special tool can be purchased on the ABT e-Line web portal.
- Likewise, the high-voltage or special tool necessary for ABT Volkswagen must be procured or rented from Volkswagen. Existing authorisation from Volkswagen High-Voltage Partners is advantageous.
- In order to sell ABT e-vehicles, a concomitant service availability is essential.

### ABT Services:

After ABT e-partner status is granted, ABT e-Line will publish the partner's contact location data on the VW dealer portal and on the ABT e-line website. By entering the profile data, the partner gives consent to ABT e-Line to publish it. This will be used to provide a map of the ABT e-partner dealer network in Germany.
